



CRAYON ART (Open Entry Exhibition)

The Marion Arts Council announces an exhibit opportunity for the young and the young at heart to create artwork using only crayons. If you are interested in this challenge... please read the following "CRAYON ART" rules and information.

1. Participants may be any age and reside in the state of Iowa or is a student in the state of Iowa.
2. Participants may produce two dimensional or 3 dimensional, original artwork. Artwork must be done using only crayons. **Coloring book artwork will not be accepted.**
3. Artwork does not have to be framed or matted. Unframed artwork will be mounted with t-pins on paper covered foam boards.
4. If you choose to frame your artwork it must include 2 hanging points that are approximately 3 inches down the side, from the top of the frame. You must also supply the wire hanger.
5. Each artist may submit up to four pieces of artwork.
6. **When the artwork is submitted a registration form must be filled out and signed.** (It may be signed by a parent if artist is not old enough for a signature.) Artwork must have a label on the back of it and have an insurance value on it. If it is for sale, the sale price must be noted, if it is not for sale, mark NFS.
7. The completed two or three dimensional artwork must be delivered to, Lowe Park Arts & Environment Center, by **Friday, November 14th, 2008, 5:00 p.m.**
(Artwork delivered after this date and time will not be accepted.)
8. Artists are encouraged to attend and invite friends and family to the exhibition reception.
9. If you would like to include a short biography about you and or your artwork, please include it on a 3"x 5" computer printed card. This will be displayed along with your artwork.
10. Artwork may be picked up on Saturday, January 24th, 2009 between 9am and noon. If this time is not convenient, you may pick up your artwork Monday through Friday, 8am-5pm or any Saturday from 1-3pm. The artwork will be in the Marion Arts Council's studio. **(Any artwork that has not been picked up by Friday, February 13th, 2009 will become the property of the Marion Arts Council.)**
